**Waiver for purchase of Martial Arts Weapons**

The National Institute of Modern Martial Arts LLC must receive signed permission from the parent or guardian of all N.I.M.M.A students under the age of 18 in order for that student to be sold, or use the “Martial Arts weapons” which are part of our Martial Arts system.

The following is quoted from the New Hampshire State Law

**RSA 159:24 Sale of Martial Arts Weapons**

- I. “Martial Arts weapons” means any kind of sword, knife, spear, throwing star, throwing dart, nunchaku or any other object designed for use in the Martial Arts capable of being used as a lethal or dangerous weapon.**
- II. Any person who shall sell, deliver, or otherwise transfer any Martial Arts weapon to a person Under the age of 18 shall be guilty of a misdemeanor (exempts parents, guardians, and those to Whom they give written permission.)**

## **BUYER'S RIGHTS**

According to NH law, RSA 358-S, we give to you the following notice of buyer's rights.

**NOTICE TO BUYER: DO NOT SIGN THIS CONTRACT UNTIL YOU HAVE READ ALL OF IT. ALSO, DO NOT SIGN THIS CONTRACT IF IT CONTAINS ANY BLANK SPACES.**

**STATE LAW REQUIRES THAT THIS MARTIAL ARTS SCHOOL REGISTER WITH THE BUREAU OF CONSUMER PROTECTION AND ANTITRUST OF THE DEPARTMENT OF JUSTICE AND MAY REQUIRE THAT THIS MARTIAL ARTS SCHOOL POST A BOND TO PROTECT CUSTOMERS WHO PAY IN ADVANCE FOR MEMBERSHIP OR SERVICES IN THE EVENT THIS MARTIAL ARTS SCHOOL CLOSES. YOU SHOULD ASK TO SEE EVIDENCE THAT THIS MARTIAL ARTS SCHOOL HAS EITHER POSTED A BOND IN COMPLIANCE WITH THE LAW OR HAS BEEN EXEMPTED FROM THIS REQUIREMENT BY THE ATTORNEY GENERAL BEFORE YOU SIGN THIS CONTRACT. IF THIS MARTIAL ARTS SCHOOL HAS NOT POSTED SUCH A BOND, AND YOU PAY THIS MARTIAL ARTS SCHOOL FOR MORE THAN ONE MONTH'S MEMBERSHIP OR SERVICES IN ADVANCE, THEN YOU ARE PAYING FOR FUTURE SERVICES, AND YOU MAY BE RISKING THE LOSS OF YOUR MONEY IN THE EVENT THAT THE MARTIAL ARTS SCHOOL CEASES TO CONDUCT BUSINESS.** (The National Institute of Modern Martial Arts only accepts membership fees on a month to month basis and is therefore exempt from posting the above mentioned bond.)

**YOU MAY CANCEL THIS TRANSACTION IN WRITING ANY TIME PRIOR TO MIDNIGHT OF THE THIRD BUSINESS DAY AFTER THE DATE OF THIS TRANSACTION.**
